
5. All of the services performed by the Receiver were necessary and proper services and have been billed at the rates approved by this Court.

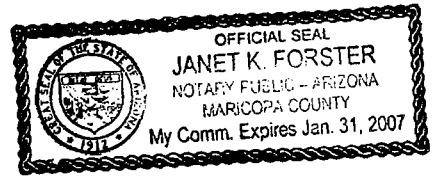
